Please correct this immediately before it can be reported. This also includes the alleys. Thanks!

# **New Mexico Primary Election:**

**Early Voting** is May 18 to June 1 Mon–Sat 10am–7pm

Closest location: Holly Plaza, 6600 Holly Ave NE (north of Paseo del Norte)

**Election Day** is Tuesday, June 4, 7am–7pm Voters may vote in any Bernalillo County voting location.

Voter registration by mail or online closes May 7.

Same-day voter registration is available in person.

Last day to request mail-in (absentee) ballots is Tuesday, May 21. Request at nmvote.org or call (505) 468-1291.



# **Beautification Committee**

I continue to pick up litter during my morning walks on our neighborhood streets and along Barstow Rd. One thing I have noticed is there has been a major uptick in dog poop being left in the gravel along sidewalks and even on our sidewalks! Animal owners, please pick up after your pets! It is not hygienic, it attracts flies and it can spread disease to other pets. I have picked up other people's dog waste; it has helped, but it is still happening especially inside our borders.

Little work was completed by the crew over the winter months as most everything had gone dormant. But now that spring has sprung we are seeing new growths of weeds and blossoms on trees and shrubs.

Faith, Adeline and I picked weeds, raked and swept up leaves along both sides of the south entrance. Our next project will be the north entrance.

No annual pre-emergent weed control was applied along Barstow to help keep weeds to a manageable level, so the beautification crew will try to keep up with new weed growth in between the junipers this spring and summer.

A reminder to all homeowners. Please keep your yards in good condition. We will again send out notices for out-of-control weeds for homes in violation of our covenants. Weed seeds easily blow to others' yards. Bagging and recycling your leaves in the fall will keep them from blowing to your neighbors' yards. We will publish the dates of the fall green pick up when they are known.

### **Pre-emergent Weed Control:**

Next spring, typically in March, homeowners might consider using pre-emergent weed control, which works by preventing seeds from germinating.

### **Help with Yard Cleanup for Seniors:**

FYI: the city has a free annual yard cleanup for those 65+ years old. If you are interested, please go to cabq.gov, look under senior services, and sign up for the programs.

### **Green Waste Spring Schedule:**

The Spring Green Waste collection is set for Monday, April 29, through Friday, May 10. Green Waste in tied plastic garden bags should be at the curb, 5 feet away from cans, by 7am on your regular trash collection day.

## **Glass Recycling:**

The Glass Recycling drop-off site was moved last year from Grace Church on San Antonio to the Albertsons parking lot at 8100 Ventura NE. Glass cannot be collected by the overhead recycling trucks. It will break and contaminate the regular recycling.

### **Being Neighborly:**

There's more and more poop being spotted left around properties and sidewalks in our neighborhood! If you are one of the folks who get out to walk your dog, be sure to clean up after they perform their "business." Please don't leave it for the rest of us!

# One Way to Help Beautify:

Covenant 21 and Amended Covenant 3 § 15 state that trash containers "shall be concealed from public view by an attractive enclosure." Many are now kept in the open in the alleys, where there is less of a beauty problem, but for those houses that have front-facing garages and no alley, they become an eyesore if they are not stored in the garage or behind a wall. Please try to comply with the Covenant.

We have had a rather quiet winter in Academy North. Several people have noticed a few things out of the ordinary and let me know. Thank you for being the eyes and ears for the police and our neighborhood. If you experience a crime, please call the police and give all the information to them. Then let me know so I can log it and send out an alert if necessary.

### October 26, 2023:

A neighbor was taking a walk up Leslynne around 2pm when she noticed an older, silver-colored sedan pull to the curb between 7204 and 7213. The driver stayed in the car and seemed to be watching the street. The neighbor kept walking, she checked again a few minutes later, and the car was gone. Somewhat disconcerting, but hopefully no crimes happened.

### **November 2, 2023:**

A neighbor on Hollis reported a young lady walking her dog along the street about the 7200 block. She stopped and was acting a bit strange digging in the leaves like she was looking for something. When asked if she needed help, the young lady became nervous and asked the neighbor to not look at her. However, the neighbor continued to ask questions and the young lady said she thought she dropped a cigarette. The young lady decided to walk south on Hollis with her dog. Our neighbor said no crime was committed, but the behavior was so strange, she wanted to report it.

### November 12, 2023:

One of our neighbors has written about a scruffy and very unkempt looking guy who is knocking on doors asking to clean windows. Just be careful when you are approached by unknown people coming to your door.

### **Porch Lights:**

Please continue to light up the neighborhood with your porch lights. But please ensure that your light fixture directs the light down, not into your neighbor's windows.

### **Garbage and Recycling Cans:**

Try to bring in your garbage cans after the trash has been collected. You don't want to leave it by the street because it will look like you are out of town, which is a signal to thieves. High winds can cause havoc especially with recycling. If yours blows away, please help your neighbors retrieve it.



# If your dog poops, Use a scoop!

In addition to dogs, did you know that city ordinance § 9-2-2-3 (B) also includes that **cats are not to be left free roaming**? The ANNA Amended Covenant 2 § 12 also requires **all** pets to be leashed in public areas. If your cat is not using its indoor kitty litter box, it is going outside, usually in your neighbor's yard, even in fenced yards.
