### Letter from the President

Hello ANNA Residents.

My we have been extremely busy this year! Our "meet your neighbor" pizza event was held Sept 28th at the new shady location on Wren Walk. We were happy that many new and established residents joined us for good food and a fun raffle.

Our annual meeting will be held in March of 2026 at the Cherry Hills Library. All residents are welcome, including renters. We elect executive officers and discuss new and pending business. You can make a difference by attending. We would love to see you all there! Watch for the signs and notifications in March next year.

I have two reminders, we have a "no solicitation" rule that is clearly marked at both our entrances. If someone comes to your door and you don't wish to engage, please remind them of that fact.

Parking issues continue to plague our neighborhood, and we will begin to address these by enforcing our covenants and with city ordinances.

City code 8-5-1-8 requires parked cars "to be headed in the direction of lawful traffic movement". I have

seen an increase in cars parked the wrong way on our streets. No one should potentially be surprised by a head on situation with someone pulling out from the curb. So please park in the direction of traffic flow. If you have guests or contractors working on your home and they park facing the wrong way, ask them to turn around and park legally.

Our covenants (6 Section 22, First Amendment) prohibit parking on our streets. This was intended with safety in mind to help keep our roads free from congestion for first responders, emergency vehicles and large city service trucks like recycle and trash pickups. This was also designed to define residents primary parking to be in garages, driveways and if applicable, along the back side of our fence lines in alleys. Street parking was not intended for daily or long-term parking or for free storage.

We have deliveries from medical supplies and equipment, FedEx, Ups and Amazon. Not to mention ongoing street sweeping and utility upgrades. All the street parking is making these services more and more difficult, ineffective and unsafe. Please utilize your garage and driveways. This is a safety issue and

a violation of our covenants. Please help support our neighborhood and ability to drive our streets safely by keeping our roads clear of parking. Landlords should be sharing this information with their tenants as well.

City code 8-1-2-28 Parking or Standing on Narrow streets, prohibits any parking on streets narrower than 24ft. This affects the north and south sides of Parrot Run and Racheleigh. So please, no curb parking on these roads outside of the pull-out areas. I'll follow up with the city for signage or painting of curbs.

# **District 4 Coalition**

In May, 6 NM legislators attended the D4 district meeting which consisted of them giving a summary of the last legislation at the round house. We had a diverse representation of 3 House members and 3 Senate members of both republican and democratic representatives. I was impressed with their thoughtfulness and sincerity in working across the aisle on championing the causes they work on. They explained the bills they are working on and briefly explained how a bill is created, edited and then sent forth to a committee. Follow up steps detailing on how bills pass through the chambers and get finalized for vote was covered by District 44 rep Kathleen Cates at the Sept D4 mtg. What a process! Very educational.

D4 Councilwoman Brooke Bassan is usually present during our meetings and summarizes what is happening in our city. 5 City Council districts are up for elections. Building ordinances still are trying to be changed and pushed for by Mayor Keller to allow for multiple usage of buildings. As of the last vote, all have been defeated. Some of these zoning code changes would have allowed for residential multiple floor expansions, tiny homes placed on residential lots, and other residential expansion without county/city permit review and without neighbor's notification or feedback. The 911 call center gave updates to a new free Smart911 app. It provides for citizens to upload a profile with pertinent information about the citizen in case of an emergency. This could help with sending the proper emergency service and provide critical information if the citizen is unable to speak, get to the door, if they have pets, existing medical conditions, allergies, etc.

This service is only provided if calling from a cellular line and the citizen controls how much information is entered. More information at the next annual meeting in March. If you cannot attend, please send request to annapresident505@gmail.com

# **Green Waste Fall Schedule:**

Fall Green Waste collection Based on earlier years, will be collected in the first 2 weeks of December. Green waste in tied plastic garden bags should be at the curb, 5 feet away from cans, by 7am on your regular trash collection day. Green waste is processed into a rough chip mulch and used to help prevent erosion at the Cerro Colorado Landfill.

Help with Yard Cleanup for Seniors: FYI: the city has a free annual yard cleanup for those 65+ years old. If you are interested, please go to cabq.gov, look under senior services, and sign up for the program.

#### **Recycling Home Collection:**

#### **Plastic Bags:**

Plastic bags must not be placed in recycling; they can clog the sorting machines. Most supermarkets have collection bins at the entrance. Please try reusable bags.

#### **Glass Recycling:**

The nearest Glass Recycling drop-off site is at the Albertsons parking lot at 8100 Ventura NE. Glass cannot be collected by overhead recycling trucks. Breaking glass contaminates the regular recycling collection.
